

Rockingham Health Center Frequently Asked Questions

Who is North Star Health? You may remember us by our legal name, Springfield Medical Care Systems. Our mission is to connect with and care for our community so all may enjoy health and wellness. We are an independent nonprofit organization employing over 200 employees across Vermont and New Hampshire. We do not profit from the services we provide. In fact, we lose about \$27 per visit on average due to rising costs of delivering care and inadequate reimbursement from insurance companies. This gap must be made up by support from the government, private foundations, and individual donors. We are governed by an all-volunteer Board of Directors where a high percentage of members are required to be patients who receive services from our health centers.

What is happening with Rockingham Health Center? As of January 1, 2025, North Star Health will no longer provide services in the Rockingham Health Center at 1 Hospital Court in Bellows Falls. This includes our Primary Care, Walk-in Services, and Behavioral Health. Services and employees will be relocated to Springfield Health Center or Charlestown Health Center (in New Hampshire). Other services in the building that are not operated by North Star Health will remain as far as we are aware.

<u>Why Rockingham Health Center?</u> Rockingham Health Center is the most costly facility in our organization to operate. Due to staffing shortages, decreased patient volume, and building disrepair, it costs more to run than it generates in revenue. To ensure we continue providing the highest quality of care, we have made the difficult decision to reduce our footprint.
